This Memorandum of Understanding ("MOU") is made and executed on 1st Feb 2022 and shall remain in effect until 1st Jan, 2027.

Information about our Central Library, Sou. Mangaltai Ramchandra Jagtap Mahila Mahavidyalay, Umbraj

The Central Library was started in 1989 along with the establishment of the college, since then library has made consistent progress in terms of books, journals, other resources and services. Now it has adequate space to provide the satisfactory service to all stakeholders. Traditional library approach is now replaced with user oriented approach with the use of technical advancement for delivering services with ICT facilities. We are providing services at our best level with optimize use of these technologies like internet facility, OPAC, e-books ,e-journals, barcode reader user tracking system, circulation with barcode scanner, N-List database etc.

Library has collection of reference books, encyclopaedias, dictionaries, biographies, autobiographies and other reading books etc. We are also providing service through N-List and NDL databases e –resources. More than 1200 books are available in the library .We subscribe more than 9 journals and magazines from various subjects and daily 5 newspapers in regional language Marathi as well as in Hindi and English. Book bank facility is provided for financially backward students at minimal cost.

(Party-B) Central Library, Smt. Vijayadevi Desai Senior College, Daulatnagar, Patan

Acting through Balasaheb Desai Foundations Smt. Vijayadevi Desai Senior College Daulatnagar to promote, among other services and facilities, access to large and relevant information resources available with BVYCLCK Library to benefit by sharing more Than 5203 books & 4 journals, Newspaper. Articles etc.

To enhance Educational and cultural exchange between Central Library, Sou. Mangaltai Ramchandra Jagtap Mahila Mahavidyalay, Umbraj and Central Library, Smt. Vijayadevi Desai Senior College, Daulatnagar, Patan.

The Central Library, Sou. Mangaltai Ramchandra Jagtap Mahila Mahavidyalay, Umbraj and Central Library, Smt. Vijayadevi Desai Senior College, Daulatnagar, Patan express their mutual willingness to establish a long-term Educational relationship and therefore agree to amend the Memorandum of Agreement executed by the parties on 1st Feb, 2022 and reaffirm their intentions for co-operation as per the amended MOU for the period 2022-2027 as follows.

I The Central Library, Sou. Mangaltai Ramchandra Jagtap Mahila Mahavidyalay, Umbraj and Central Library, Smt. Vijayadevi Desai Senior College, Daulatnagar, Patan agree to cooperate in the areas of public education, academic research, conservation, exhibition, information sharing, promotion and publicity, publications.

II Central Library, Sou. Mangaltai Ramchandra Jagtap Mahila Mahavidyalay, Umbraj and Central Library, Smt. Vijayadevi Desai Senior College, Daulatnagar, Patan agree to exchange certain publications (including books and periodicals) and other academic materials for reading only.

III In particular, several initiatives are underway, planned or under discussion:

A. Scholarly collaborations and Programs between the Central Library, Sou. Mangaltai Ramchandra Jagtap Mahila Mahavidyalay, Umbraj and Central Library, Smt. Vijayadevi Desai Senior College, Daulatnagar, Patan for proposed exhibitions and installations.

B. To strive for the overall development of the library.

5.1 Material Format

Supplying Library is encouraged to lend as liberally as possible regardless of the format of the material requested such as audio-visual material and other categories of material that have traditionally been non-circulating.

5.2 Confidentiality

The Supplying Library has a responsibility to retain the confidentiality of the individual requesting the material. The sharing of the user's name to others is not, of itself, a violation of confidentiality.

5.3 Timely Processing

The Supplying Library has a responsibility to act promptly on all requests. If a Supplying Library cannot fill a request within a reasonable time, then it should respond promptly at earliest.

5.4 Identifying the Request

The supplying library should send sufficient identifying information to the requesting library to identify the issued reading material. Such information may include an issue reference number or related screenshot showing transaction details etc.

5.5 Due Date and Use Restrictions

5.5.1 The Supplying Library should clearly indicate the date on which it expects the loan to be discharged in its circulation system. Additional period should be suffixed to a definite date that have room for the sending and return of material as well as sufficient time for the use of the material.

5.5.2 The Supplying Library is encouraged to grant the renewal request if the material is not needed by the local users.

5.6 Suspension of Service

A Supplying Library is encouraged to address the problems to the Requesting Library before termination of service.

D. That the faculty members of the respective parties may also be allowed to use the CD/DVD & audio cd devoted to highly technical subject as well as computer lab.

E. The both the parties will keep constant interaction with each other for academic Excellence to benefit each other.

F. That there will be no service charges for inter library facility.

IV This amendment to the original Memorandum of Understanding comes into effect upon signing by representatives of the Central Library, Sou. Mangaltai Ramchandra Jagtap Mahila Mahavidyalay, Umbraj and Central Library, Smt. Vijayadevi Desai Senior College, Daulatnagar, Patan and shall remain in effect until 31st Jan, 2027. On the expiration of this MOU, it may be extended or amended by both parties in written form.

Either Party may terminate this MOU at any time by giving an onth's written notice to the other Party.
